100th Meeting of the Approval Committee under the Chairmanship of Administrator (IFSCA), under sub-section 2 of Section 13 of SEZ Act, 2005, is **scheduled to be held on 17th April 2026 at 2nd Floor, IFSCA HQ, Pragya Tower, GIFT SEZ, GIFT City, Gandhinagar in Hybrid Mode.**

2. All applicants who wish to set up an IFSC unit in terms of sub-rule 1 of Rule 17 of SEZ Rules, 2006, in GIFT IFSC, are advised to **submit their application in Form-FA through SWIT System/SEZ Online portal, as the case may be, as informed vide PUBLIC NOTICE NO. 01/2024-25 dated 04.10.2024 issued by this office. The applications shall be filed latest, by 13th April 2026 (01 PM).** Any difficulties faced while filing the application may be taken up with the NDML team [Sh. Nirav Mehta – niravm@nsdl.com and Sh. Abhishek Apte - abhisheka@ndml.in] (or) IFSCA IT Team [Sh. Ashwath ashwath.balaje@ifsca.gov.in], as the case may be, with a copy to ifsca-admin@ifsca.gov.in
3. The applicants who are applying through the SEZ portal, as they are not yet covered under the SWIT System, are advised to submit their IFSCA application to the respective IFSCA Regulatory Team, along with the SEZ Application, before the deadline dated **13th April 2026 (01 PM)**
4. It is informed that the applicants may ensure that the SEZ/SWIT application filed by them is complete in all respects. **An incomplete/defective application filed on (or) after 01/03/2025 in SWIT System/SEZ Online portal, shall not be taken up for consideration of UAC.** Such applications shall be **returned in the SEZ Online portal** with deficiencies raised by the O/o the Administrator (IFSCA) for appropriate rectification. The application shall be taken up in the UAC only after all the deficiencies, if any, are rectified. The applicants may refer to the **Public Notice No. 04/2024-25** issued in this regard.
5. It is informed that the deadline for rectification of deficiencies shall be **15th April 2026 (01 PM).**

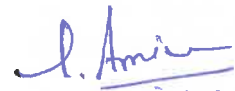
