Recruitment of Assistant General Manager (Officer Grade C) on Deputation basis

- I. The Government of India has recently set up the International Financial Services Centres Authority (IFSCA), which is a statutory body under IFSCA Act, 2019. The Authority will function as a unified regulator and is empowered to exercise the powers of RBI, SEBI, IRDAI and PFRDA in respect of respect of financial services, financial products and financial institutions performed/located in the international financial services centres in the country. The Authority invites applications from eligible Indian citizens for the post of Assistant General Manager (Officer Grade C) on Deputation basis.
- II. ASSISTANT GENERAL MANAGER (Officer Grade C) Total number of posts expected to be filled is 2 as below:

III. Pay and Allowances: As admissible to Assistant General Manager (AGM), IFSCA. The present applicable scale of pay for Assistant General Manager is Rs. Rs. 77950-2850(3)-86500-3100(2)-92700-3300(4)-105900-EB-3300(2)-112500-3550(1)-116050 (13 years)

The monthly gross emoluments at the beginning of the pay scale work out to Rs 2.35 lakh.

IV. ON DEPUTATION BASIS

The candidates appointed on Deputation basis would have the option to draw pay and allowances as admissible to him/her in the parent organization or the scale of pay as admissible in IFSCA

- V. Age limit as on May 31, 2023: Not more than 56 years of age.
- VI. Experience as on May 31, 2023: Candidate must possess not less than 6 years of experience as Group A Officer in All-India Service/ Central Civil Services/Regulatory bodies, Central/State Statutory /Autonomous/Subordinate Authorities, or an Officer in RBI, SEBI, IRDAI, PFRDA Banks, Financial Institutions, academic Institutions and the experience shall be in dealing with the activities relating to securities market, Insurance, Banking, Pension, financial products and financial services.
- VII. Desirable experience: Preference will be given to officers having legal background and worked in the legal policy and legal affairs related to Banking, Capital Market, Insurance and Funds. Further, for AGM (Insurance), prior work experience in Insurance and reinsurance operations will be preferable.
- VIII. Term of appointment: The appointment for the post will be on deputation basis for a period of three years and extendable up to 5 years. The candidates applying for the post of Assistant General Manager on deputation basis should route their applications through their employer. Candidates applying on Deputation basis should also furnish Vigilance Clearance (major / minor penalties, if any, imposed during last 10 years), Cadre Clearance and Annual Confidential Reports for last 5 years along with the application. Incomplete applications will not be considered. In case non-receipt of the abovementioned documents on or before the date of interview, the application shall be summarily rejected.

IX. GENERAL INSTRUCTIONS:

- 1. Applications which are incomplete, or received after the prescribed date will not be considered.
- 2. Mode of Selection will be Interview. The Authority reserves the right to modify the selection procedure, if deemed fit.

- 3. Candidates should satisfy themselves about their eligibility for the post applied for. The Authority shall determine their eligibility and only eligible candidates will be called for Interview.
- 4. The applications that are required to be routed through the employer will not be considered if it reaches the Authority after the due date even though submitted to the employer before the due date. In such cases, application marked 'Advance Copy' should be sent to Authority and the regular copy should be routed through the employer.
- 5. The Authority reserves the right to raise the minimum standards in respect of qualification and experience in order to restrict the number of candidates to be called for the Interview. Thus, merely fulfilling the eligibility conditions laid down in the advertisement as regards qualifications and experience, would not automatically entitle any candidate to be called for the Interview.
- 6. The IFSCA reserves the right to fill all the posts and right not to fill up the post at all. The Authority shall reserve the right to decrease or increase the number of posts to be filled in case ofbest suitability.
- 7. The Authority reserves the right to cancel the advertisement fully or partly on any grounds.
- 8. Canvassing in any form will disqualify the candidate.
- 9. If the candidate is not eligible or have knowingly or willfully furnished incorrect or false particulars or suppressed material information, his/her candidature will be liable to be cancelledat any stage of the selection. If the candidate qualifies in the selection process and subsequently it is found that he/she does not fulfill the eligibility criteria, his/her candidature will be cancelled and if appointed, he/she will be repatriated without any notice or compensation. Action as deemed fit will be initiated.
- 10. Applications received after due date will not be entertained. The Authority takes no responsibility for any delay in receipt of application or loss thereof in postal transit.
- 11. The decision of Authority in all matters would be final and binding, and no correspondence in this regard would be entertained.
- 12. Candidates who satisfy the eligibility norms may apply giving their bio data strictly in the prescribed format.
