In this regard, we wish to inform you that there is a delay in finalising the lease deed and submitting the same to your good self within 6 months of the date of Letter of approval i.e., 24 January 2024.

The delay is because the FME is yet to commence its operations, as the Fund launched by the FME in the GIFT SEZ i.e., NX India Opportunity Gift Trust is still in the process of:

1. Obtaining certain registrations required for a unit to operate in GIFT SEZ, i.e., IFSCA registration, GST registration, Importer Exporter Code and Registration-Cum Membership Certificate, and

2. Fund raise and execution of fund-related agreements.

We kindly request your approval for an extension to finalize and submit the lease deed accordingly.
