Till date, the unit has not submitted the lease deed.
- 3.1.4 Reason for Delay in Submission of Registered Lease Deed: (From-Catamaran Artha IFSC LLP)

While processing the SEZ Online Request ID **192400002992** for granting LOA Extension till 20.08.2025, the unit submitted a request letter dated October 3<sup>rd,</sup> 2024, that states the following:

"We, Catamaran Artha IFSC LLP ("Catamaran Artha"), received the Letter of Approval ("LOA") vide Ref. No. F. No. GIFT/SEZ/DCO/II/59/2023-24/dated August 21, 2023, for setting up a new IFSC Family Investment Fund (FIF) in the GIFT City.

We request you to kindly grant us an extension of the LOA appropriately, considering the final approval to take off full-fledged family office functions under IFSCA regulations is pending with the esteemed office of the IFSCA. We request your good office to kindly condone the delays in applying for the Renewal of the LOA as well as the non-execution of the lease deed for our Registered Office premises.

We assure you that Catamaran Artha is very committed to commencing FIF operations as soon as possible and look forward to your approval."

### 3.1.4. Rule 18(2)(ii) of SEZ Rules applicable in this case is as under:

"a copy of the registered Lease Deed shall be furnished to the Development Commissioner concerned within six months from the issuance of the Letter of Approval and failure to do so, the Approval Committee may take action to withdraw the Letter of Approval after giving an opportunity of being heard".

**Decision of 25<sup>th</sup> UAC:** The Approval Committee after deliberation **deferred** the request **with the below remarks** 

### Remarks:

1. The applicant submitted that there is no regulatory clarity on their

Authorized operations and hence, they are yet to obtain regulatory approval from IFSCA. Due to procedural issues, they have not yet paid the rent to the Developer (GIFTCL) for the occupied premises and hence execution of the lease deed is pending. The applicant further indicated that they are still in the process of making a final decision regarding the establishment of the entity.

2. The UAC took note of the applicant's submission and advised them to finalize their decision in consultation with IFSCA and communicate the same to the office of the Administrator (IFSCA) at the earliest, positively in the month of December itself. The UAC decided that the matter may be deferred till then.

- **3.2.2. Daga Business International Stock Brokers IFSC Private Limited** has set up the IFSC Office at Unit No. 228, Signature Building Second Floor, Block 13B, Zone-1 Gift SEZ, Gandhinagar- 382355. The LOA of the unit expired on **06/05/2024**. A **renewal request was filed by the unit** on **27/06/2024** with **Request ID: 202400004601**.
- **3.2.3.** It has been informed by the IFSCA Supervision team that a Warning Letter dated 14.08.2024 was issued to the unit as, when IFSCA officials visited the registered premises of Daga Business (International) Stock Brokers (IFSC) Private Limited, only temporary/clerical staff were present. The unit has submitted in its reply dated 21.08.2024 that on the date of IFSCA visit, the Compliance officer was present in Noida for their Board Meeting. Subsequently, they have changed their Compliance Officer as a measure for material staff strength.

#### 3.2.4. Decision and remarks from 25th UAC:

**Decision of 25<sup>th</sup> UAC:** The Approval Committee after deliberation **deferred** the request **with the below remarks** 

### Remarks from 25<sup>th</sup> UAC:

The entity informed that they are a wholly owned subsidiary of DB International, and the parent entity has an office in Unit No. 221 in the same building. The representative also informed that they have had changes in their Compliance Officer and their earlier Compliance Officer was based out of the Delhi-NCR region. They have recently appointed a person based out of Ahmedabad as the Compliance Officer. The entity was unable to represent effectively before the UAC due to repeated technical issues at their end. UAC advised the Office of the Administrator (IFSCA) to email a detailed questionnaire to the Unit, based on their oral submissions before the UAC. The Administrator (IFSCA) has recommended that the authorized representative of the entity, who is well-versed of the matter, may attend the next

UAC meeting in person to answer all queries after submitting their written responses to the questionnaire.

- 3.2.5. Following the UAC 25<sup>th</sup>, the Office of the Administrator (IFSCA) sent a detailed questionnaire vide mail dated November 11, 2024, to the Unit and received the following responses on November 21, 2024:
- Q1. Is there any other entity related to M/s. Daga Business International Stock Brokers IFSC Private Limited which is operating in GIFT City, either in DTA or SEZ? If yes, please provide the details of the same along with the address.

The registered office of the Company is located at Unit No. 210/211/211A, 2nd Floor, Dalal Street Commercial Cooperative Society Ltd, Block No. 53, Zone 5, GIFT City, Gandhinagar, Gujarat-382355.

While processing the SEZ Online Request ID **192400002981** for granting LOA Extension till 30.06.2025, the Office of the Administrator (IFSCA) called the Unit to the UAC with the following comments:

"The Unit shall submit the copy of registered lease deed which shall be merged with existing documents already submitted by the Unit on SEZ Online portal and same shall be uploaded on SEZ Online portal. Unit may also be called to the UAC for non-submission of Lease Deed."

### 3.3.3 Reason for Delay in Submission of Registered Lease Deed: (From- FS Ashika Ventures IFSC Private Limited)

"[...] We are currently in the process of obtaining all necessary approvals for our Fund. Unfortunately, there have been delays in the commencement of operations due to the time taken to secure the IFSC approval (Certificate of Registration) for the Fund Management Entity (we obtained it in April 2024, more than 6 month after LOA issuance).

We kindly request your assistance and cooperation in extending the validity of our LOA."

### 3.3.4. Rule 18(2)(ii) of SEZ Rules applicable in this case is as under:

"a copy of the registered Lease Deed shall be furnished to the Development Commissioner concerned within six months from the issuance of the Letter of Approval and failure to do so, the Approval Committee may take action to withdraw the Letter of Approval after giving an opportunity of being heard".

3.3.5. The unit has not submitted a Lease Deed till date. In view of Rule 18(2)(ii) of the SEZ Rules, 2006, the Approval Committee may like to decide on the delay in the submission of the lease deed by this unit and grant a further extension, as requested by the Unit.

<u>Decision of UAC</u>: The Approval Committee after deliberation **deferred** the request with the below remarks-

### Remarks:

- 1. The applicant informed that they are in the process of executing the lease deed. However, the delay is attributed to procedural issues on the part of the Co-developer, though they are uncertain about the exact cause. The UAC noted the submission and advised the applicant to send a detailed email to the Office of the Administrator (IFSCA) outlining the chronology of events.
- 2. The UAC further recommended the applicant to have an in-person meeting with the Office of Administrator (IFSCA) to give clarity on the challenges faced by them in executing the Lease Deed.

Request you to kindly note we are not registered under Goods and Service Tax (GST) as the mandatory requirement to get our Company registered in GST is Letter of Allotment issued by SEZ which already expired. For getting registered under Goods and Service Tax (GST) we need extension of LOA."

**3.4.3.2** Further, during the meeting with SEZ Division, IFSCA on 30.09.2024, the unit informed that they are yet to execute their Lease Deed. From the documents available in the physical file, it is found that the unit is **yet to even submit the BLUT for approval.** 

### 3.4.4. Rule 18(2)(ii) of SEZ Rules applicable in this case is as under:

"a copy of the registered Lease Deed shall be furnished to the Development Commissioner concerned within six months from the issuance of the Letter of Approval and failure to do so, the Approval Committee may take action to withdraw the Letter of Approval after giving an opportunity of being heard".

### 3.4.5. Decision and Remarks from Previous UACs:

<u>Decision of 21<sup>st</sup> UAC Meeting</u>: The Approval Committee after deliberation deferred the request with the remarks below

### Remarks:

 The representatives of the Unit informed that they could not execute the Lease Deed initially because they were not aware of the process and thereafter due to certain technical reasons and dependencies on other compliances. They further mentioned that they were asked to vacate the

- office space on March 31st, 2024, and since then the Unit has not had office space in the GIFT-SEZ which they are now in the process of getting.
- 2. The UAC noted that the LOA has expired for the Unit, and they do not have the underlying office space with them.
- 3. The Unit was advised to consult the officials of the Office of Administrator (IFSCA), provide all required details/documents to enable officials to examine and find out the possible solution in the matter. Post that the matter may again be brought to the UAC for consideration.

<u>Decision of 26<sup>th</sup> UAC Meeting</u>: The Approval Committee after deliberation deferred the request with the remarks below

### Remarks:

- 1. It was noted in the UAC that the applicant submitted a detailed set of documents including email communications made with the office of the Administrator (IFSCA). It was noted by the UAC that the applicant had sent short emails requesting LOA Extension from July/August without any documents supporting their case for an LOA Extension. Further, it was observed by the UAC that the applicant had been locked out of their SEZ Online portal also and they had been in touch with the relevant NSDL authorities to retrieve their SEZ Online portal account.
- 2. The UAC deliberated on the complexity of the matter and accordingly advised that a joint meeting between the Office of the Administration (IFSCA), the Developer (GIFTCL), a representative from the relevant IFSCA regulatory team, and the applicant may be held explore the available options and the way forward.

**3.4.6.** As advised in the 26th UAC Meeting, a joint meeting was conducted on 19th November 2024 in hybrid mode. Subsequently, as discussed in the said meeting, the applicant submitted an invoice issued by the Developer (GIFTCL) as proof of possession of the premises on which the LOA was issued. As per the said invoice, the entity has paid rent till 31.12.2024 and has shown possession of the premises.

3.4.7. The Approval Committee may like to decide on the delay in the submission of request for LOA Extension by the Unit.

<u>Decision of UAC</u>: The Approval Committee after deliberation condoned the delay in filing the LOA Extension request and decided that the request for LOA Extension may be processed on merits.
