- i. The office of Administrator (IFSCA) informed the UAC that there are 03 cases where the applicant had obtained approval from the UAC but has not made the necessary application/rectification of deficiencies in the SEZ portal so that LOA may be issued. The UAC was informed that generally applications shall be scrutinized and taken up in the UAC only after all the documents are submitted and deficiencies are removed. However, in the interest of ease of doing business for GIFT-IFSC units, the applications are included in the UAC Agenda even with deficiencies in documents and later the missing documents are obtained from the units.
- ii. The UAC was apprised that the LOA that is granted under SEZ Act/Rules shall be valid for one year from the date of issuance and that the SEZ Act/Rules do not provide for ever-greening of the approval given by the UAC. The approval given by the UAC is not a blanket, perpetual approval that the unit may choose to exercise in the future at their convenient time and date for obtaining LOA.
- iii. In this regard, it was proposed to the UAC that the units may be given a maximum time of 15 days from the date of UAC to rectify the deficiencies raised in the SEZ portal. In case the applicant resorts to inordinate delay in rectifying the deficiencies, then the effective date of issuance of LOA shall be 30 days from the date of UAC.
