Reason for Delay in Submission of Registered Lease Deed: (From M/s. Sandhill Aviation IFSC Private Limited)

- Amidst this process, the authorized representative of the company Mr. CA Rohan Thakkar, our consultant and authorised representative was detected CKD (Chronic Kidney Disease) and was on dialysis. He went through kidney transplant operation on 11th January 2023 and was in ICU for the period of 15 days. Thereafter he was quarantined for few months and it took a time for him to continue the operations. And even after that also his health was not up to the mark and he was working very remotely and for the few hours a day
- Due to unavoidable circumstances (and more particularly it was under belief that since the aircraft has been booked, as a reasons, it is on the verge of generation of the invoice the moment the aircraft reaches the unit) the company could not make an application for further extension before the expiry of the above period i.e., 19.09.2023.
- While going for the lease deed registration, it is learnt that the LOA needs to be renewed.
- Consequently, on 15.04.2024, an application for extension of LOA was made before the office of the Development Commissioner
- On 16th April 2024, the e mail in this regard was forwarded to the office of the IFSCA Administrator.

- It is humbly requested to condone the delay in making extension application for a period of 209 days (Calculated from 19.09.2023 to 15.04.2024).
- It is humbly prayed to grant extension as:
- a. The unit wants to commence the operations and the unit will do the same as soon as the aircraft is received by it. The booking amount has already been given for the same It is humbly requested to your good office to condone the delay in filing extension application and grant us the extension for the further one year.

It is requested to please grant us an extension till 01.08.2024 in Lease Deed Registration."

The unit has not submitted a Lease Deed till date. In view of Rule 18(2)(ii) of the SEZ Rules, 2006, the Approval Committee may like to decide on the delay in the submission of the lease deed by this unit and grant a further extension.

Decision of UAC: The Approval Committee after due diligence and deliberation **approved** the request and granted an **extension till 19.09.2024** for submitting the Registered Lease Deed. The unit was also advised to get their LOA extension completed and also file the intimation of commencement at the earliest. **Remarks: N/A**

Discussion on efficient utilization of the available office space

After taking up all the New Unit Approval and other miscellaneous applications, the attention of the Committee was drawn to the issue of some Co-Developers issuing PLOA in the premises that are yet to be completed/be suitable for regular office use. It was decided by the Committee that the applications filed by such entities who have been allotted such incomplete premises may not be taken up in the agenda until the applicant submits a new PLOA with functional office premises. Further, it was felt that all the Co-Developers may be sensitized and discouraged about issuance of PLOA against incomplete/not-usable premises.

It was also proposed that GIFT being the Developer may consider developing

and promoting a centralised database from where all new applicants may get to know about all the ready and vacant/available premises. In this regard, the representative of DGFT informed that such a database is available on the website of other SEZs and therefore it was felt that GIFT may also consider implementing similar system in its website.
