12	Comments from Unit	"We are writing to respectfully request an extension of the validity period of our Letter of Approval(LOA) bearing reference number IFSCA-SEZ/88/2024-SEZ, dated June 07, 2024, issued by the International Financial Services Centres Authority (IFSCA), granting us registration as a Broker-Dealer under the IFSCA (Capital Market Intermediaries) Regulations, 2025, vide Registration No. CMI2025BDK018, dated May 01, 2025. We received the Provisional Letter of Allotment (PLOA) from Volupia Developers on December 18,2024, which, as we later came to understand, was valid for a period of 60 days. Unfortunately, we were unaware of this time-bound condition and, due to this inadvertent oversight, could not fulfill the mandate to get our office premises registered within 6 months of the LOA issuance date. We deeply regret this lapse and assure you that it was not intentional but occurred due to our unawareness of the time constraints associated with the PLOA validity.
		We therefore request your kind support in granting an extension of the LOA validity till 30 th September 2025 to enable us to fully comply with all the requirements and provisions laid down by IFSCA.
