All applicants who wish to set up an IFSC unit in terms of sub-rule 1 of Rule 17 of SEZ Rules, 2006, in GIFT IFSC, are advised to **submit their application in Form-FA through SWIT System/SEZ Online portal, as the case may be, as informed vide PUBLIC NOTICE NO. 01/2024-25 dated 04.10.2024 issued by this office. The applications shall be filed latest, by 10th February 2025 (6 PM).** Any difficulties faced while filing the application may be taken up with the NDML team [Sh. 3. The applicants who are applying through the SEZ portal, as they are not yet covered under the SWIT System, are advised to submit their IFSCA application to the respective IFSCA Regulatory Team, along with the SEZ Application, before the deadline dated **10th February 2025**.

4. It is informed that the applicants may ensure that the SEZ application filed by them is complete in all respects. It may be noted that **an incomplete application shall not be taken up in the UAC meeting.**


