3. The applicants who are applying through the SEZ portal, as they are not yet covered under the SWIT System, are advised to submit their IFSCA application to the respective IFSCA Regulatory Team, along with the SEZ Application, before the deadline dated **12th March 2025 (5 PM).**

It is informed that the applicants may ensure that the SEZ/SWIT application filed by them is complete in all respects. **An incomplete/defective application filed on (or) after 01/03/2025 in SWIT System/SEZ Online portal, shall not be taken up for consideration of UAC.** Such applications shall be **returned in the SEZ Online portal** for appropriate rectification and shall be taken up only when the complete application is submitted. The applicants may refer to the **Public Notice No. 04/2024-25** issued in this regard.
