



MEETING NOTICE

Subject: 1st Meeting of Approval Committee for IFSC Units- Reg.

Ministry of Finance vide Notification No. S.O.940(E) Dated: 28.02.2024 amended certain provisions of SEZ Act, 2005 and Rules, 2006, whereby sub-section (7) was inserted to section 12 of the Special Economic Zone Act, 2005 as under:

'7. "Notwithstanding anything contained in this section, in case any Units requiring recognition, registration, license or authorisation by the International Financial Services Centres Authority established under sub-section (1) of section 4 of the International Financial Services Centres Authority Act, 2019 (50 of 2019), the powers and functions of the Development Commissioner under this section, except the powers conferred under sub-section (3), shall be discharged by an officer nominated by the International Financial Services Centres Authority to be designated as "Administrator (IFSCA)".'

2. Accordingly, IFSCA vide its Public Notice No. F.No. 15256/2024/EPA dated: 07.03.2024 designated Shri. Praveen Trivedi, Executive Director, IFSCA as an Administrator (IFSCA) under sub-section 7 of Section 12 of SEZ Act, 2005.

3. Pursuant to same, 1st Meeting of Approval Committee under the Chairmanship of Administrator (IFSCA) under sub-section 2 of Section 13 is **scheduled to be held on 22nd March, 2024 at 2.15 p.m at 2nd Floor, IFSCA HQ, Pragya Tower, GIFT SEZ, GIFT City, Gandhinagar in Hybrid Mode.**
