- Accordingly, the UAC has approved the project and advised the office of the Administrator (IFSCA) to issue the LOA only after confirmation from the IFSCA Regulatory team.

Decision of UAC: The Approval Committee after due diligence and deliberation, approved the project, subject to the standard terms and conditions of the SEZ Rules, 2006, regulatory approvals from IFSC Authority, compliance with all applicable Acts, Rules, and Regulations, and the compliance / Submission of documents/ Remarks mentioned below:

Remarks:

- 1. The UAC observed that the premises mentioned in the PLOA submitted by the applicant unit is already occupied by a different entity named 'IC Legal'. The applicant submitted that IC Legal is a partnership firm which has been demerged into 02 different units - one of which is IC REGFIN LEGAL PARTNERS LLP. They further stated that the operations of IC Legal in IFSC will be taken over by IC REGFIN LEGAL PARTNERS LLP and any further invoicing will be from IC REGFIN LEGAL PARTNERS LLP only.
- 2. It was noted that LOA for IC REGFIN LEGAL PARTNERS LLP cannot be issued in the same address when the premises is with some other unit. The applicant unit requested that they shall be filing a request for change of address for IC Legal and that the firm IC Legal will be operating from that new address for the purpose of completing their surrender of IFSCA Licence and exit from SEZ.
- 3. Consequently, the UAC while in principally agreeing for the issuance of LOA, advised the office of the Administrator (IFSCA) to issue the LOA to the applicant unit only after the address change request from the 'IC Legal' is approved.

Observations and Suggestions from the representative of the Development Commissioner's Office:

The representative from the office of the Development Commissioner, GIFT-SEZ submitted that the Development Commissioner has made the following observations:

1. Background scrutiny of Parent Entities:

It is necessary to verify the credentials of the parent entities of the applicants intending to set up IFSC units within the SEZ. This step is necessary to ensure the legitimacy and financial soundness of the applicants.

2. Employment generation:

It has been observed that the employment figures provided by certain entities are not commensurate with their reported import or investment values. The representative highlighted that while entities project a higher number of employees during the application stage, the actual hiring often falls short.

The representative further suggested that any deviation from the core activities permitted under the IFSC framework, as well as any malpractice related to the use of resources, must be strictly prohibited and subject to regular scrutiny.

Response from the Office of the Administrator:

The suggestion was duly noted by the Unit Approval Committee (UAC).

In response, the Office of the Administrator clarified that with regard to point (1), the IFSCA Regulatory team does a complete evaluation of the credentials and background of the parent entities and whether they meet the "fit and proper" criteria before approving the IFSCA Registration.

Furthermore, it was informed that the IFSCA Supervision Team is regularly conducting surprise visits and inspections to ensure compliance with prescribed norms and to deter any irregular practices. Any irregularities noticed in the SEZ procedures is shared with the office of Administrator (IFSCA) and necessary action is initiated under SEZ provisions also.

The Administrator (IFSCA) invited any positive and practical suggestions/solutions to the recommendations given by the DC office.
