- With respect to all queries received with respect to reservation of posts for recruitment to the Grade of Assistant Manager (Grade A) of IFSCA – 2024 vide Notification dated 27.03.2024, it is informed that Grade A is a single cadre and considered equivalent to Group A Service of the Government of India. All reservations have been calculated in terms of various orders/instructions issued by the Government of India on this matter, as contained in the 'Compendium No.36011/1/2022-Estt(Res-I) (as updated from time to time)'
- 2. Candidates seeking reservation/ relaxation benefits available for SC/ST/OBC/EWS or any other category must ensure that they are entitled to such reservation/ relaxation as per eligibility prescribed. At the time of the interview, they should also be in possession of all the requisite valid certificates in the prescribed format in support of their claim as stipulated for such benefits and these certificates should be dated earlier than the crucial date (date of interview)
- 3. A person seeking appointment on the basis of reservation to EWS must ensure that he/she possesses the Income & Asset certificate valid for the financial year 2024-25 issued by a Competent Authority on the basis of gross annual income of FY 2023-24 in the format prescribed by Government of India. Candidates may please note that they should be in possession of "Income and Assets Certificate" as mentioned above issued on or after 01.04.2024 and before the date of document verification at the time of interview. 'Income and Asset Certificate' shall be submitted by such candidates at the time of interview (if called for interview). No request for extension of time for production of 'Income & Asset Certificate' beyond the said date shall be entertained.
- 4. Candidates belonging to the OBC (NCL) category should be in possession of OBC (NCL) certificate issued on or after 01.04.2024 and before the date of document verification at the time of interview. OBC (NCL) certificate shall be submitted by such candidates at the time of interview (if called for interview). No request for extension of time for production of OBC (NCL) Certificate beyond the said date shall be entertained. In case candidates fail to produce the same at the time of interview, they will not be allowed to appear for interview. Further, their request for interview under General category will also not be entertained.
- 5. Candidates who have appeared at a qualifying examination the passing of which would render them educationally qualified for the IFSCA (Recruitment of Officer Grade A 2024) Examination but have not been informed of the result will also be eligible for admission to the IFSCA Examination. All candidates who are declared qualified by the IFSCA for appearing in interview will be required to produce proof of passing the requisite qualifying examination, failing which such candidates will not be admitted to interview.
