Part C - Any other matter that the committee decides to take up for consideration

- 1. The representative from GIFT requested that the details/copy of new LOAs issued, letters approving address change may be provided to them by the office of Administrator (IFSCA) and stated that the DC office used to submit this information to them regularly. The representative from DC office informed that their office used to submit this information when the matters were being processed on physical file and that they had not shared any such information with GIFT since the DC office started processing SEZ matters through the portal. The Committee requested the Developer to coordinate with NSDL and obtain a view-only login in the SEZ Online portal so that the requisite information may be downloaded directly from the reports available in the portal.
- 2. Further to the discussion on the New Unit application taken up in the subject meeting, the representative from GIFT informed that there are various entities who had been defaulting on rent payments for many months and they are not contactable by the Co-Developers also. They further requested that these units may be issued exit/lapse orders and that it was already done by the DC office. It was discussed and agreed that these units need to be formally moved out of the SEZ so that their addresses may be allotted to the other prospective and genuine applicants. The UAC advised that GIFT may furnish a comprehensive list of such defaulting units to Administrator (IFSCA) and it was also decided that a meeting may be held with the Co-Developers before the next UAC to discuss the issue of defaulting entities.
