

Compliance with Remarks: Vide email dated 27.03.2024, the applicant has submitted the requisite Board Resolution.

The Approval Committee had a discussion on the following issues during the course of the meeting.

- Use of Table desk Spaces for obtaining LOA: It was noted by the Committee that many applicants have obtained PLOA in table-desk provided by developer / Co-Developers. The Chairman noted that the table desk space was envisioned as a temporary arrangement to accommodate the units entering the IFSC area till the time sufficient infrastructure is set up by the Developer/Co-Developers. The Chairman also observed that it is desired that the units shall work from fully functional office spaces only. The Committee further urged the Developer GIFT to make available the office spaces required for the units to function at full capacity. The representatives from GIFT assured that office spaces in commercial buildings are on the verge of completion and expected to be made available for full usage from the months of July-August 2024. Further, it was informed that Co-developers have been provided a land area to create dedicated plug and play units to facilitate units requiring smaller office space in SEZ area.
- Verification of the premises shown in the PLOA: It was brought to the notice of the Committee that certain premises where PLOA has been issued, may not have been completed and accordingly it was agreed that the status may be verified from the office of Development Commissioner, GIFT SEZ.
