

- 3.1. Sub: NX Financial Management Services IFSC LLP: Request for extension of time for submission of the executed registered lease deed. (as per the provision of SEZ rule 18(2) (ii))
- 3.1.1. Brief Summary of the Case
  - 3.1.1.1. LOA File No GIFT/SEZ/DCO/II/15/2023-24 Dated: 25.07.2023
  - 3.1.1.2. Validity of Original LOA: 24.07.2024
  - 3.1.1.3. First LOA Extension till 31.12.2024
- 3.1.2 NX Financial Management Services IFSC LLP has set up the IFSC Office at Unit No. GB-14, Seat Nos. 1 and 2 Ground Floor, Pragya Accelerator Block-15, Zone-1, Road No.11, in GIFT Multi services SEZ Phirozpur and Ratanpur Gandhinagar- 382355. The unit was supposed to submit the lease deed as per the rule, this must be done within 6 months of issuance of the LOA (i.e.- 24th January 2024). But NX Financial Management Services IFSC LLP has not submitted the lease deed till date.
- 3.1.3. Reason for Delay in Submission of Registered Lease Deed: (From NX Financial Management Services IFSC LLP)

We, NX Financial Management Services IFSC LLP ('FME'), refer to the Letter of Approval dated 25 July 2023, bearing reference number F. No. GIFT/SEZ/DCO/II/15/2023-24/587.

In this regard, we wish to inform you that there is a delay in finalising the lease deed and submitting the same to your good self within 6 months of the date of Letter of approval i.e., 24 January 2024.

The delay is because the FME is yet to commence its operations, as the Fund launched by the FME in the GIFT SEZ i.e., NX India Opportunity Gift Trust is still in the process of:

- 1. Obtaining certain registrations required for a unit to operate in GIFT SEZ, i.e., IFSCA registration, GST registration, Importer Exporter Code and Registration-Cum Membership Certificate, and
- 2. Fund raise and execution of fund-related agreements.

We kindly request your approval for an extension to finalize and submit the lease deed accordingly.

#### 3.1.4. Rule 18(2)(ii) of SEZ Rules applicable in this case is as under:

"a copy of the registered Lease Deed shall be furnished to the Development Commissioner concerned within six months from the issuance of the Letter of Approval and failure to do so, the Approval Committee may take action to withdraw the Letter of Approval after giving an opportunity of being heard".
