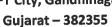

32.3.2.1 The IFSCA Supervision team (IFSCA) has submitted that M/s. Marwadi International Securities IFSC Limited has reported Net Worth below the required level specified by NSE IX and that all CMIs are mandated to not conduct any new or existing business until Net Worth is restored as per Circular dated 05.09.2024.

32.3.3. Thus, it is observed that,

a. the applicant entity has not conducted any activity/operations in the past 05 F.Y. of the first

b. In Q2 of the current F.Y., the entity has not even met the Minimum Net worth requirements of the IFSCA Regulations, and they are not supposed to conduct any business activity under IFSCA Regulations until they meet the Net worth requirements.
