VistaJet Leasing IFSC Private Limited has set up the IFSC Unit at Unit No. GB -28, Seat No. 1-4, Ground floor, Pragya Accelerator, Block -15T, Road 11, Zone-1, Processing Area, GIFT SEZ, GIFT City, Gandhinagar-382355. The Organization was supposed to submit the lease deed as per the rule, this must be done within 6 months of issuance of the LOA (i.e.- by December 1, 2023). But M/s. VistaJet Leasing IFSC Private Limited has not submitted the lease deed till date.

## Reason for Delay in Submission of Registered Lease Deed: (From M/s. VistaJet Leasing **IFSC Private Limited Application**)

- "(a) In terms of the requirements set forth in Rule 18(2)(u) of the Special Economic Zones Rules, 2006 ("SEZ Rules"), VJ Leasing was required to submit a copy of the registered lease deed with the good office of the Development Commissioner of GIFT-SEZ within six months from the date of the Letter of Approval. Accordingly, the last date for submission of the duly executed and registered lease deed was 1 December 2023,
- (b) On 21 November 2023, we submitted an application dated 21 November 2023 ("First Extension Application") to the office of the Development Commissioner and requested an extension of 2 months (i.e., till January 31, 2024) for submission of the executed and registered lease deed in view of the circumstances and reasons which were beyond our control and were set out in detail in the First Extension Application. Please refer to the First Extension Application attached herewith as Annexure-B'
- (c) While we had provided all the requisite documents (including eligibility certificates and the final certificate of registration issued to us by the IFSCA) to Savvy ATS Realty LLP ("Lessor") as per their requirements, we did not receive any satisfactory response or cooperation from the Lessor towards finalization of the lease deed despite the fact that we have always made full payments of the lease rental for the leased premises. As a result, we had to seek another extension of 2 months (i.e. till 31 March 2024) from the good office of the Development Commissioner for submission of the lease deed.
