## <u>Financial Action Task Force (FATF) High risk and other monitored jurisdictions –</u> <u>February 24, 2023</u>

The Financial Action Task Force (FATF), vide public statement 'High-Risk Jurisdictions subject to a Call for Action' dated February 24, 2023, has called on its members and other jurisdictions to refer to the statement on these jurisdictions adopted in February 2020 and October 2022.

Further, FATF had earlier identified the following jurisdictions as having strategic deficiencies which have developed an action plan with the FATF to deal with them. These jurisdictions are: Albania, Barbados, Burkina Faso, Cayman Islands, Democratic Republic of Congo, Gibraltar, Haiti, Jamaica, Jordan, Mali, Mozambique, Panama, Philippines, Senegal, South Sudan, Syria, Tanzania, Turkiye, Uganda, United Arab Emirates and Yemen. As per the public statement, **Nigeria, and South Africa have now been added** to the list of Jurisdictions under Increased Monitoring while **Cambodia and Morocco have been removed** from this list based on the decision made at the February 24, 2023, FATF plenary. Such advice does not preclude the regulated entities licensed/ recognized/ registered or authorized by IFSCA from legitimate trade and business transactions with the countries and jurisdictions mentioned there.

The FATF plenary releases documents titled "High-Risk jurisdictions subject to a Call for Action" and "Jurisdictions under Increased Monitoring" with respect to jurisdictions that have strategic AML/CFT deficiencies as part of the ongoing efforts to identify and work with jurisdictions with strategic Anti-Money Laundering (AML)/Combating of Financing of Terrorism (CFT) deficiencies.
